# **Outlaw Tees Expands**




As Bob Dylan's song says "the times they are a changing," and that is true at Outlaw Tees. When the business started in 1984, it was a one-man shop in a two-car garage; after 38 years it was up to seven employees in a 4400 square foot building. In the early days the shirts were all printed manually, which worked fine for shirt orders around 100; but when they started getting in the 1000 range, Outlaw Tees entered the automatic printing world, which allowed faster turnarounds and controlled quality prints. Outlaw Tees not only did shirts for local businesses and schools; they created a niche

market in the car show circuit. Their designs have been shipped all over the United States to over 80 shows a year.

Over the past few years, the increase in business had John and Connie trying to find options to reduce their workload. They were looking for a suitable buyer or a shop to handle just the printing portion of the business with John doing just the designs and signwork. They found a printer: Lance Ingwersen. Lance has operated Maleo Designs, a one-man shop for the last seven years. Lance will be running the Iowa Outlaw Tees operation from his shop at 113 West Main, New London, Iowa. The shop, a 9300 sq. foot building in the center of town, originally was built for the town's hardware store and most recently housed the Linkin Center Banquet Hall. Customers will be able to place and pickup orders at both the New London and Nauvoo locations.

## Nauvoo City Council Meeting January10, 2023

The Council, under pro tem mayor Tacy Nelson, unanimously approved the following:

- To donate \$100 to the Hancock County K-9 Fund to "reimburse" Chief of Police Ryan Dykstra's use of a county phone while on duty in Nauvoo.
- Temporary (60-day) approval of a Policy Manual for Police, giving aldermen time to review the manual and temporarily giving the Nauvoo police force a working policy manual in the interim.
- \$50 per diem and use of police squad care for Bryton Hopp and Colton Hardy to attend a Breath Alcohol Operator Training class in Macomb.
- A \$1/hour pay raise to City employee Brenden Siegfried.
- An amount not to exceed \$1,000 to send Public Works Director Barry Cuthbert to the Illinois Rural Water Association Conference in Effingham in February. This includes payment of the conference registration fee (\$190), per diem (\$84), mileage (\$300), and lodging (\$235).
- The purchase of new forks, to replace reworked and unsafe forks for present backhoe, for \$3,400.
- To direct the City Attorney to prepare an ordinance to increase City Water & Sewer rates by 3% (to keep up with increased cost of chemicals).
- The expenditure of \$968.68 for radio installation (needed to monitor the new community center building's sprinkler system).
- To award to Heaton Environmental the contract for asbestos sampling at the old school building behind the new community center. The city will pay \$6,672 plus \$30 per sample for testing on suspect material. Total cost not to exceed \$10,000.
- To accept the winning bid of \$950 from John Jones for property no-longer-needed by the City: (1995 F150 pickup (\$200), 2006 F250 Super Duty pickup (\$250), and a 75 Galleon Road Grader (\$500))
- To accept the winning bid of \$8,010 from Brandon and Andrew Schoen for a 580 Backhoe.

Nauvoo Community Center. John McCarty, speaking on behalf of the Nauvoo Community Center Capital Campaign Committee (NC5) reported that the new community center building is 95% complete. There was a installation holdup until January 23 because the HVAC units had to meet new federal requirements. The original contract with Schickedanz Construction included a 5-foot wide sidewalk around the perimeter of the building, which cannot be done until the weather gets warmer. A discussion followed about whether or not to terminate the current contract with Schickedanz WITHOUT the perimeter sidewalk, and put out a new bid request for the parking area as well as the perimeter sidewalk. No decision was made as the NC5 needs to consult with the City Attorney and research the Library Grant requirements first. [The City will conduct a walkthrough before assuming total responsibility for the building. NC5 will plan a grand opening at a time TBD.] McCarty also advised the City Council that they will need to decide many issues that are outside the purview of the NC5, including: policies for facility rental, use of the lobby area by groups for displays, etc., parking areas for city employees, the public, and tenants at the former school building, trash removal, what to do with the current library and city hall buildings, and the feasibility of maintaining the old school building. McCarty also pointed out that the congregation of Christ Lutheran Church, whose church and parsonage was auctioned off recently, made a \$23,000+ donation towards the new Community Center, along with folding tables, chairs, and a piano.

Crosswalk Possibility: Alderman Jim Boyles talked about the study of putting a crosswalk at the intersection of IL96 (Mulholland) and Bluff Streets. This would include four handicapped curbs at the four corners (Temple Parking Facility, Zion's Mercantile, State Bank of Nauvoo, and the southeast corner of the Temple Block). This would require the loss of one parking space in front of the bank and Zions Mercantile. No action was taken at this time.

## **Nauvoo Fire Protection District (NFPD)**

At the monthly NFPD Board of Trustees meeting last Thursday evening, the board voted to purchase a 2023 ambulance that had been used as a demo, which was more readily available for delivery. There were \$12,410 in additional costs: lighting, graphics, striping, for a total cost of \$192,300 plus the cost of \$8,003.06 for a new radio.

Chief Gallaher reported that he has been in discussions with the Dallas City FPD to provide Ambulance Services for the Hancock County portion (plus all of Dallas City) of their district. He also reported that NFPD responded to 43 fire incidents and 323 ambulance incidents for a total of 366 incidents during 2022.

## **Nauvoo Chief of Police**

Ryan Dykstra has been Nauvoo's Chief of Police since October 2022. From 2013-2016 he worked for the Sheriff's office, as well as part-time in Nauvoo. In 2019 he returned to Nauvoo as a deputy, becoming Chief in 2022. Ryan served two years in the army, was injured, and elected to retire with full benefits rather than to stay in the military and settle for a desk job. One

of his goals is to combat the methamphetamine (aka "meth") problem in Nauvoo, which he suggests is as high as 5-10% of the city's population and affects all ages from late teens to those in their 80s. Ryan feels that more media attention should be paid to prevention, as once addicted, the possibility of stopping is extremely difficult. To compound matters, meth now is prepackaged and readily available for purchase. (As a side note, methamphetamine, aka "meth," was introduced by the British in WWII. Both the Allied troops and Germany used meth to increase their troops' effectiveness by keeping them alert and awake for long periods of time during battle.)

Nauvoo's police department is made up of part-time employees. At present Ryan is looking for someone to work morning hours (8-4 a.m. would be ideal). Interested? Contact Nauvoo City Hall at 217-453-2587.) Aside from on-the-job concerns, Ryan enjoys spending time with his German shepherd, Sheriff (wouldn't another dog named "Deputy" be neat!), and working out at the gym. He has a Facebook page that he invites the public to follow. Nauvoo welcomes Ryan.

# Money from the Lutheran Church

Last year Christ Lutheran Church held its last service. The church, parsonage, and contents eventually sold, leaving \$457,677 for the congregation to make a final distribution that resulted in preselected set amounts to eleven entities, seven of them in Hancock County: Nauvoo Food Pantry (\$5,000), HUGS (\$5,000), Nauvoo Public Library (\$5,000), Bright Angels (\$500), Living Water (\$3,000), Nauvoo Senior Citizens (\$1,000), and Quilting for Warriors (\$500).

Ten preselected entities received percentages, which were much greater than anticipated due to the unexpected price of the sale total, each totaling \$23,341. Two were from Hancock County: Nauvoo Community Center and CARE. The remaining eight included Camp Callahan Trinity Lutheran (Carthage), Immanuel Lutheran, Talbot Sober Living Residence, Chaddock (Quincy), QUANADA, and Lydia's House (Keokuk). The ELCA Synod received a percentage of \$215,089. Church Treasurer Tom Haas, personally handed out the checks, leaving recipients with smiles on their faces and gratitude in their hearts.

Christie and Darren Adair from Cedar City, Utah, purchased the church building and parsonage. The Adairs are very interested in receiving input from members of the community regarding possible uses of the property that could actively serve the people of Nauvoo. Ideas?
