Wednesday, May 17, Is Clean-up Day in Nauvoo

(Please note, the following items are accepted from resident garbage customers only.)

- Curbside-accepted items need to be out by 6:00 a.m.: (Household/patio furniture (cut to manageable size), mattresses, lawn decorations, toilets, small amounts of lumber (cut to 5' lengths), windows, doors, fencing, wiring, small plumbing pipe, swing sets (cut down), bicycles, lawnmowers/tillers (gas and oil drained), toys, bowling balls typewriters, shoes, clothes, batteries (automotive, motorcycle, lawnmowers, jump boxes, etc.)
- Items accepted at the City Parking Lot from 8:00 a.m. to 2:00 p.m.: Appliances and metal.
- Items accepted at City Hall from 8 a.m. Noon and 1 5 p.m. p.m.: Electronics (computer towers, laptops, printers, fax machines, copiers, industrial/commercial electronics, cell phones, radios, cable/satellite components, car batteries, fans, LCD monitors, game systems, etc. (NO TVs!)

Items NOT Accepted during spring clean-up: Concrete, bricks, yard waste, anti-freeze, liquid paint, motor oil, gas, freon, herbicides, pesticides, asbestos materials, large amounts of drywall, vehicles, etc. (NO TIRES!)

City Council Minutes April 11, 2023

The Church of Jesus Christ of Latter-day Saints presented a site plan for a new Visitors Center across the street (Wells) from and north of the Temple. The Planning Commission reported reservations about the location, as presented, and did not make a recommendation to approve the plan as presented. Jordan Bodily, Facilities Management Director, will speak on behalf of the Church and address the various concerns. Many of the aldermen, along with Bodily, expressed their concerns that the new facility would increase traffic along Wells Street in front of Sts. Peter & Paul Church, which is already congested during Sunday mass as well as for special events like funerals and weddings. Various ideas were presented: making Wells a one-way street, closing Wells to vehicular traffic entirely, or making the west side of Wells a "no parking" zone, etc. The Council voted to table the matter and reconsider it at a special City Council meeting on April 25th at 7:00 p.m. [Note: The special meeting was cancelled prior to printing of newsletter.] (See following article for more information about the proposed Visitors Center.)

The City Council unanimously approved the following:

- Mowing contract (several City properties and the cemeteries to Josh Plate, at \$670 per mowing.
- The FY 24 City Budget.
- Purchasing BAM Weather Services, an app that covers weather within a 10-mile radius of Nauvoo, gives access to a live meteorologist and would pinpoint tornados in the area. (Currently the City gets its weather information from the Quad Cities and St Louis. The cost is \$2,400/year (if we sign up for five years) and comes with a 30-day free trial.
- Granting full-time employees an average raise of 3%, amounting to about \$0.68 an hour.
- Purchasing a water tower mixer, which keeps chlorine at a constant level throughout the water tower and prevents ice from forming. Federal funds (\$9,950) would be used for this purchase and includes the hiring of a contractor to inspect the water tower tank.
- Replacing the dilapidated aluminum clarifier skirting with new stainless-steel skirting. Federal funds (\$72,000) would be used for this purchase.
- Making the final payment to Schickedanz for construction of the new Community Center building.
- Issuing a special event liquor license to Sts. Peter & Paul School Cook-off (April 21, 5-8pm).

Other:

- Tabled a request by Jordan Bodily to allow short term use and occupancy of some of the apartments (those used for missionary housing) in the Outdoor Museum District. These apartments would be used as a convenience by district Temple volunteers who live far enough away to make daily commuting an inconvenience. The apartments would be used for a few nights each at no cost.
- Acting Mayor Nelson reported that Constellation Electric would provide electricity to Nauvoo residence unless they opted out. This is because of the Nauvoo Municipal Electric Aggregation program approved by voters in 2011.

Nauvoo Fire Department District (NFPD)

The NFPD accepted and signed a formal agreement providing ambulance services to the Dallas District and discussed the purchase of a technical rescue trailer (ca. \$4,000) that would assist in performing grain-bin rescues and other specialty incidents. NFPD's concerns re: Nauvoo's present and proposed TIF District caused considerable discussion, centering on the perceived loss of property tax revenue and possible future losses. The Department wants to make sure everyone is fully educated regarding how TIF districts affects all taxing bodies. Several proposals were offered, including making a formal request for TIF funding from the City of Nauvoo to assist the NFPD with completing a large, proposed project to expand and aesthetically improve the NFPD's current firefighter training facility, which is currently located inside of a white shipping container placed on the edge of NFPD's This would also provide area firefighters with an property. improved firefighter training experience and, possibly, allow Nauvoo to become a regional training center and, thus, receive a better ISO (insurance) rating for homeowners. According to Chief Gallaher, the NFPD already has certified fire instructors on staff and all the other equipment required to become a regional training center; becoming one would possibly open the door for new grantfunding opportunities. The Board members directed Chief Gallaher to begin the process of speaking with the City of Nauvoo about future steps.

Chief Gallaher reported that there were 32 calls in March. Four were fire-related incidents, 27 were for emergency medical services, and one was for weather-spotting.

New Visitors Center Planned for Nauvoo



The plan for the proposed Visitors Center includes a 120-space parking lot on Young Street between Wells and Durphy, location of the former cheese factory. The 24,000 square foot structure is slightly larger than the present Visitors Center, which was built in the early 1970s. Administration offices will remain at that site. The new Center would be built into the hill with a basement and a low profile near the Historic Temple City on the flats in the Outdoor Museum area. Amenities include a lobby, restrooms, gallery, exhibits, a film introducing visitors to Nauvoo, classrooms, and activity rooms. Once approved, construction could begin this fall and be completed in two years. The parking area would be open to the public.

"Mess" at East Edge of Town Sold

The property at the east edge of town has long been referred to as "the mess," a large overgrown concrete footprint for a facility that never materialized. The owner defaulted, and the property went to the contractor, Meller Excavating & Asphalt. It has been for sale for a number of years. The February listing of deed transfers in the April 19, *H.C. Journal Pilot* listed the property as being sold to Rendar Holdings LLC, North Las Vegas, Nevada. It will be interesting to see what the future plans for the site will be.

The non-profit organization enjoyed thirteen years entertaining audiences. Laurie Peterson retired as manager in 2022 and new manager Mikilana Jackson assumed the role. However, it was short lived. In March, Mikilana notified the members of the Orchestra's demise as there were fewer and fewer musicians at all levels of expertise available. (Members ranged in age from 10 to senior citizens.) She expressed her gratitude for all those who participated and supported the orchestra. Nauvoo will miss the orchestra and commiserates its passing.

Memorial Day's Picnic in the Park





Don't Be Gullible and/or "Click Happy"



According to Police Chief Ryan Dykstra, professional scammers are looking for you—especially if you aren't tech savvy, which, unfortunately, makes many older folks who fall into this category easier to victimize. Not only do scammers involve the individual, but impact families, as well, as they try to straighten the problems caused by their relative buying into the scam. Often the problem is not reported to the police.

It is so easy to click on a link without

being aware that a scam is in progress. Chief Dykstra has the following advice:

- If you don't know the source, don't click on it.
- If you didn't sign up for something you've "won," you didn't win anything.
- If payment is requested to receive the "prize," there is no prize.
- If payment is required for purchasing a gift card (which is totally untraceable), it is a scam with no reimbursement for your loss.
- If you get a message with a phone number attached, DON'T call it!. (Ex. If a Pay Pal, Walmart, Amazon, email, etc. says you need to call a number, find out if the number is legitimate first BEFORE dialing.)
- Beware of fundraisers emailed to you. They can be "sucker bait."
- Beware of pressure tactics that encourage you to make a quick decision in order to get the "best" deal.
- Scammers prey on people who follow the rules and those who are gullible. If it sounds too good to be true, it probably is. Scammers are clever and are ALWAYS looking for opportunity.

Chief Dykstra is making a concentrated effort to get the word out. Forewarned is forearmed is the best way to combat the con "artist." If you think you are being victimized in this way, call the Hancock County Sheriff's office for immediate attention at 217-357-2115. Pick up related pamphlets available at City Hall or check Ryan Dykstra's Facebook page, which has up-to-date information.

Beside scams, con men (and women) are clever and are ALWAYS looking for opportunity: obituaries, when remaining loved ones are vulnerable and out of the house for funerals; keys left in cars; unlocked houses, etc. Beware. Be aware.

Have you been "bitten" by the bug of tracing your family tree? Many have been and have found the perfect "antidote" at Nauvoo's Family Search Center on the corner of Bluff and Knight. Thirteen computers have been set up with five search

programs available for amateur or professional ancestor sleuths. Two excellent programs available are "Family Search" and "Ancestry" (of DNA fame).

With the exception of Pageant season (July), the time spent at a computer is unlimited. (It helps to bring a thumb drive for ease in copying anything pertaining to your ancestors. However, scanning and copying information is also available.) To make the process even easier, at least two people (who know what they're doing!) are available to assist in finding information and navigating the various programs. A digitalizing service is also available for the scanning of old photographs, slides, and negatives. All this for no cost.
