

For those of you living here, it was like being put on a spin cycle, finding out everything was still damp, so you put the spin-cycle up higher and hit the start button again! For those of you NOT in town. . . pretend you have a blind fold on and then get stuck in a SALAD SPINNER!! Remember that scene out of the Wizard of Oz where the witch is riding her bicycle in the tornado??? Yep, it's accurate.


The worst of the deluge was slowing by 11:00am and we could actually see the Police truck that is parked right behind City Hall. Carol and I took a couple seconds to check on our families that were in range and then we looked at each other and said WHAT JUST HAPPENED. Throughout the day we would experience relief every time we answered our cell phones to a familiar voice and knew someone else was safe. That was the beginning of "no phones, no lights, no motor cars, not a single luxury."

After sustaining straight-line winds, that included some as strong as 100 mph, Hancock County was left with 36% of Ameren electric customers without power. The first email I received from Ameren Illinos was at 11:07am Thursday informing me that my power was off -that was the first of many texts and emails.

Many neighborhoods in town were in motion almost before you could blink. Neighbors checking on neighbors and getting geared up for some long days of hard work. I am ever grateful that we, as a City, have so many resources available in an emergency. From the City Guys out there immediately getting roads open to the Fire Rescue crews making sure they could still respond to emergencies that can arise during chaos. This little town didn't break under pressure, we managed to say #WeAreNauvoo and got moving.

Fast forward, 4 days, many cold showers, grilled meals, and flashlight batteries later, and here we are. Most if not all of the town is back online as I type this. Many of us have experienced amazing acts of selflessness and moments of great emotions. As we recover and regroup let's not forget how good it feels to HAVE a neighbor that cares and how good it feels to BE a neighbor that cares.

#### June City Council June 13, 2023

#### The City Council acted on:

- Unanimously disapproving the location of the site plan for the proposed Historic Visitors Center and parking lot as submitted by the Church of Jesus Christ of Latter-Day Saints [See April and May editions of the newsletter for additional information.] The Planning Commission indicated the proposal was not adequate [not all of the required documentation was included] nor accurate [zoning] as submitted. In addition, several were present to speak against the location of the building. An new proposal would have to be resubmitted to the Planning Commission.
- Directing the City Attorney to draft an amendment to City Ordinances to allow the installation of four-way stop signs at the intersection of Wells and Young Streets, the posting of four "School Zone" signs, and the enforcement of them.

#### Other:

- Gene Shurts expressed his concern about the speeding on Parley Street and the need for more speed limit signs at that location. He also suggested looking into a room divider for the new Community. Center meeting room.
- Nauvoo Community Center Capital Campaign Committee (NC5) member ,John McCarty, reported that the one [and only] bid for parking and landscaping for the Community Center came in at least 40% above anticipated. NC5 will scale down the proposal and resubmit. [The building cannot open until all ADA requirements are met: sidewalks, parking, etc.] Once these are in place, and the building is open, the other landscaping issues will be met.

#### The Nauvoo Fire Protection District Board of Trustees June 15, 2023

#### The Trustees unanimously approved the following expenses:

- Up to \$30,000 for an expansion project on the district's current firefighter training facility. Fire Chief Kendall Gallaher informed the board that some of the ground preparation work will be a donated service provided by a local organization. The goal is to have the project completed by August 9.
- Up to \$3,000 to purchase firefighter PPE for a new member of the department
- Up to \$3,000 for the purchase of a brush guard for the front of the new ambulance

#### Chief Gallaher reported:

- an increase in fires throughout the region recently. The weather has been dry and windy, and more people are out later in the evenings.
- He also reported that he has received complaints from concerned citizens regarding nightly rentals in Nauvoo that may be exceeding their occupancy limits, which could be a fire hazard. He will be talking to the owners/operators to ensure they are complying with state and local fire codes.

**Free Library Card For Minors:** Due to a new law passed by the State of Illinois, every non-resident (defined by library law as anyone living outside of Nauvoo city limits) minor 17-years old and under may receive a free library card. If you are living in an area that previously disqualified your minor child for a free library card, that child is now eligible. Stop by the library anytime to get your child signed up for a free library card, and they may begin checking out materials, ordering materials in from around the state, accessing free e-books and audiobooks, and more! We have already had a massive response, and we are so happy to see so many more kids receiving access to books!
